PRIVACY POLICY

PROTECTION OF INFORMATION

What type of information does duBreton collect?

If you save personal information on our website (by creating a user account or choosing a password, performing a product search, placing an order, providing information in your account) or if you we transmit personal information via any form of electronic communication (communication via Facebook, telephone, participating in a contest, completing a survey form or promotion), we can obtain and save this information.

duBreton's website is for adult use only. duBreton does not collect any personal information from children aged 13 and under. Guests aged 13 and under should not use the duBreton's website or provide personal information to duBreton.

Does duBreton collect information about me?

duBreton may use your personal information for:

- Process your orders and answer your questions;

Does duBreton share information about me with third parties?

At no time do we sell or rent your personal information to third parties as prescribed by law.

We reserve the right to disclose your personal information in the cases required by law, as part of court proceedings, in response to a request from law enforcement authorities and, if necessary, to protect personal information. property, interests, and rights of duBreton.

How can I exercise my choices regarding the receipt of advertising information?

What is a cookie and how are cookies used on the duBreton website?

How long is personal information kept?

We will only keep your personal information as long as it is reasonably necessary to do so for the purposes stated in this policy or as required by law.

How is personal information protected?

We have taken appropriate measures to maintain the confidentiality of personal information and protect it against loss or theft, as well as unauthorized access, disclosure, copying, use or modification, considering, in particular, their sensitivity and the purposes for which they are used. In addition, we require that each employee, agent, or representative of duBreton respect this policy.
